#### APPLICATION INSTRUCTIONS

Before starting the application, the grass area is mowed to a height of 2 cm. In this way, the grass leaves remain upright and BARS grass dye can reach all the yellowed and dried areas underneath. The grass area is raked with a suitable rake, without damaging the grass leaves, and foreign materials and dead plant materials are removed from the area.

## **LIMITATIONS**

To obtain optimum quality, please adhere to the application instructions. Application should be made between +5 C and +30 C. Application should not be made in hot, rainy and windy weather. Application should not be made on surfaces at risk of frost. The product should be protected from rain, water, frost and negative external factors until it is cured.

## **CONSUMPTION**

An area of 10-15 m<sup>2</sup> can be painted with 1 kg of grass paint.
